## DELAYED SERVICES, BANKS, OTHERS HINDER SMOOTH PORT OPERATIONS

Port operations are not perfect at this critical period, as inefficient service delivery by terminal operators and shipping companies have been identified as bane for smooth operations. Besides, skeletal operations by banks is also posing a challenge to shippers and clearing agents in a bid to take delivery of cargoes.

The Nigerian Shippers Council (NSC), which revealed this to The Guardian, said it also observed that some shipping companies and terminals do not have adequate waiting areas, thereby exposing clearing agents and other users of their services to the elements.

Executive Secretary, NSC, Hassan Bello, therefore urged shipping companies and terminal operators to create an atmosphere that makes it possible to achieve physical distancing and other health and safety guidelines within their premises.

"All freight forwarders should comply with the selfdistancing guidelines as well as well as other health and safety regulations. ## THE OIL INDUSTRY'S GLUT HAS A BRIGHT SPOT: TANKER STORAGE

The price of oil has plunged, but the price of finding a place to put it has soared. And if you are in the business of providing a temporary home for the world's glut of crude, you've hit the jackpot.


More and more massive tankers at sea are being used simply to hold the oil - as much as two million barrels per vessel - until it is wanted. Other vessels are busy carrying it to buyers like China, which is taking advantage of prices not seen in two decades.

Tankers are in demand, and their rates, as low as \$25,000 a day in February, have ballooned to nearly \$200,000 a day, even hitting almost \$300,000 at one point.

"We are one of the few industries making money in this period," said Hugo de Stoop, chief executive of Belgian-based Euronav, one of the world's largest tanker companies. The current market for vessels, he added, "is totally and completely unusual."

Oil companies have been chartering Euronav's very large crude carriers, or V.L.C.C.s – tankers longer than three football fields – for \$150,000 to \$200,000 a day, Mr. de Stoop said, depending on where they are going. As it costs about \$18,000 a day to run a ship – for expenses like paying and feeding a crew of 25 – profits at the moment are huge

## 20 COUNTRIES SIGN PACT TO KEEP PORTS OPEN FOR TRADE

Port authorities in 20 countries across three continents have signed an agreement to keep ports open for trade amid the coronavirus pandemic, in a move initiated by Singapore.

From Los Angeles to Antwerp, and Abu Dhabi to Shanghai, the countries recognised, in a virtual roundtable, that the maritime sector plays a critical role in keeping trade flows open during this period.

The port authorities committed to working together to ensure merchant ships can still berth at ports to carry out cargo operations and keep the global supply chain going, the Maritime and Port Authority of Singapore (MPA) said on Friday.
